ASCTACON21 Trade Exhibitor Terms & Conditions

In order to be accepted as an ASCTA Event Trade Exhibitor, Trade Exhibitors must agree to the following Trade Exhibitor Trade Exhibitor Terms and Conditions

- Site allocation is at the absolute discretion of the Convention organisers. Payment must be received when registering to secure a Trade Exhibitor space. Confirmation of receipt of payment will be provided by return email
- Trade Exhibitor sites will be based on historical precedent and package level, notified preferences, space requirements and receipt of payment and agreement to the Trade Exhibitor Terms and Conditions within the required time frame. The provisional site will be notified to Trade Exhibitors, 14 days prior to the event, but is subject to change without notice for whatever reason including but not limited to events beyond the control of ASCTA.
- ASCTA reserves the right to restrict the type of products on display or promoted where conflicts exist with ASCTA core business products or that of its sponsors. Trade Exhibitors must notify ASCTA if:
 - intended activities, promotions or displays involve anything that will increase the potential for accidents e.g. use of fireworks, throwing challenges/games/chemical demonstrations etc.
 - any accident or injury arising as a result of the Trade Exhibitors actions or products whilst at the Trade Exhibition
- The allocated site is for the Trade Exhibitor and their usual business and range of products. The Trade Exhibitor entering into this agreement is to be the only entity trading from the allocated Trade Exhibitors site. No Trade Exhibitor may sub-let part of their site (with or without payment) to third party entities without written permission from ASCTA. Where a Trade Exhibitor has an affiliate they wish to trade beside this should be indicated in site location information
- No signage may be placed outside of the designated Trade Exhibitor area e.g. toilet areas, over railings, lift area etc.
- Trade Displays are not to block emergency exits, signage or fire-fighting equipment
- All electrical equipment should be compliant to Australian Standard 3760 - 1990
- All Trade Display products may be left "in situ" overnight at the Trade Exhibitor's own risk. ASCTA will not be held responsible for any losses or damages whatsoever. ASCTA may be able to arrange with the venue providers a limited number of cloth covers suitable for covering Trade displays
- ASCTA may take photographs and video (including audio) of Trade displays for use in publicity, promotions or in any way ASCTA so determines via any means of communications
- ASCTA asks that all Trade Exhibitors be cognisant that presentations and meetings are occurring between breaks and that excessive sound may cause distraction at these times
- ASCTA will use its best endeavours to provide all benefits listed in the Trade Exhibitor package chosen, but some benefits are limited in number
- Inclusion of promotional products or material in attendee's handouts is subject to ASCTA having the material to hand within the agreed timeframes. It is also subject to sufficient product or material being available
- Delivery timelines of promotional products or material and displays will be provided with confirmation of agreement and payment. Address labels for promotional products and materials and for delivery of Trade Exhibitor Displays will be provided. Courier Drivers and deliveries or pick-ups should be directed to the Sea World Resort & Conference Centre loading dock during weekday working hours. Palletised loads are acceptable. It is the responsibility of the Trade Exhibitor to ensure deliveries are received within the required timelines.
- Free car parking is available at the Sea World Resort and Conference Centre at the Trade Exhibitors own cost.
- Due to a large amount of pre-event printing, contextualised presentations and preparation being undertaken by ASCTA, any Trade Exhibitor cancelling from 15 July, 2021 onwards will still receive some of the listed benefits. A fee equivalent to 30% of the selected Trade Exhibitor package will be retained by ASCTA for cancellations received between 15 July, 2021 and 31 August, 2021. ASCTA will retain a fee equivalent to 60% of the selected Trade Exhibitor package from 1 August, 2021 onwards
- Payments for additional function tickets cannot be refunded within 48 hours of the event. An Administration Fee of \$50.00 will be charged for all Convention Registration cancellations
- An Administration Fee of \$20.00 will be charged for all reissued Tax Invoices / Receipts
- Trade Exhibitors are encouraged to consider insurance for cancellation, travel and accommodation interruption, loss or damage to merchandise and other potential or perceived risks
